## ABCUSA MATTHEW 25 GRANT APPLICATION

A generous donor has given a sum of money through American Baptist Churches USA to be used for programs that address "housing, feeding, education and health with regard to the less fortunate." A panel will select recipients for grants of up to \$5,000 largely based on the degree to which the funds will be used to directly assist persons described above. The applying ministry must be directly affiliated with American Baptist Churches USA to be eligible to submit an application. Only one application per church or region will be considered within a 24-month period. Grant funds may not be used to fund staff positions, rainy day fund, church benevolent fund, or for capital improvements to facilities. Grant awards will be sent to the ABC church or Region that is applying for the grant; checks will not be made payable to an individual or ministry.

MSM provides services for local familes through requests made my the caseworkers of the Human Services department (600 such requests and counting in our four years of existence). The funds would be used to help one of our three areas of emphasis, in this case household goods (The three are home repair and ramps, rides to medical appointments, and household goods). The Household Goods programs provides beds (always new, never used) for those who have none, and also purchases appliances (fridges, washing machines) or kitchen tables/chairs when we do not have enough donated used items to meet the need. In 2015, these requests totaled nearly 100 new beds and a total expense of over \$23,000. The pace of requests for 2016 has only grown, through July of 2016, we have spent over \$22,000 to provide beds/appliances directly to needy families, \$10,000 over our budged pace. We would thus utilize any grant funds received to ensure that all of the requests in the remainder of 2016 that we receive are able to be filled.

- 4. How will the funds assist individuals battling poverty and its effects? What impact do you hope to make on the target group or community? All of those whom MSM helps are active clients of the Human Services Department (CYS, Aging, MH/DS), and are thus nearly always the most vulnerable members of our community and those with the least resources to meet their needs {They are also people whom the caseworkers cannot help through the normal chanels, MSM is a last resort for them to help their clients}. Our goal is to help those in a crisis situation (one where their health/safety/dignity is at stake) in order to allow them the stability to better their own situation, in many cases allowing children to remain with their families and keeping families from becoming homeless. While MSM is offering real and concrete help to meet a specified need, we also offer to pray with those we help, offer them a Bible, and follow-up by asking the nearest local church to contact them. It is the hope of MSM that our help during their time of need will open the door to the call of the Gospel, that those amongst us with the weakest family and societal connections might eventually become part of the family and kingdom of God.
