Weirton Christian Center has been a making a difference in the community since 1917. Our preschool serves children three, four and five years of age. The Afterschool Program It exists as a ministry of the Weirton Christian Center in Weirton, West Virginia...available 4 days a week.

Mission: Serving God and Community with an emphasis on Children; meeting their spiritual, physical and mental needs.

The Weirton Christian Center has been serving the Community for 99 years and as the community has changed, so have the needs of our families, and the programs of the Center. For years, Weirton Christian Center offered the ONLY Kindergarten in the city until it was taken into the School system. We soon after started a 4-year old pre-school. Since 2006, our focus has been a developmental Christian Curriculum that meets state standards. We opened up to 3-year olds, in anticipation of the addition of Pre-K to the public schools. We also offer a free Afterschool and Summer program to children from Kindergarten through High School. In 2015, we served a total of 278 children throughout the year.

Many families do not have transportation, so we now offer free transportation, to and from our free program for 3 to 5 year olds daily from 9 AM to 1 PM. Our Christian Curriculum teaches Bible verses daily, as well as Christian music, Christian pledges and character virtues, how to pray, and much more. At this age, they are like sponges and as we pour God's Word and ways into them we are even affecting others in their homes. Many come from homes where parents are in jail, or rehab and our area is now number one in heroin overdoses for the state of West Virginia. Most of our children in the afterschool program are on free lunch at school and our neighborhood is very low-income. We pull from all over the city, but there is so much need. We find at the end of the month many of our families are out of food. Some because they are stretched by their incomes, and others because they may sell the food stamps for half of their value in order to purchase drugs. Either way, the children are hungry and that is not OK. In the past, we have provided a substantial snack for our preschoolers, but this year, we have hired someone to prepare lunch and they will also receive a "breakfast" snack when the children arrive. This past year, we started including the PreSchool students in our Blessing Bag Distribution that sends food home enough food to sustain them on long weekends, especially at the end of the month. Our request for funding includes \$100 per week for 80 Pre-School Lunches for 38 weeks of classes – a total of \$3,800.

After hearing from teachers and our children that they had no food on long weekends (especially the end of the month) and when there were numerous snow days, we started providing "Blessing Bags" to our After School Students. This includes breakfast, lunch and dinner foods as well as snacks. Longer weekends or holidays mean larger bags with more meals. We would like assistance in adding the 3 and 4-year-old preschoolers to our Blessing Bag ministry each long holiday/school weekend. We've broken down the average cost of a 3-day blessing bag to average \$9 per child, so for 20 children it would total \$180 each time – for six different distributions November through May. Blessing Bag sponsorship request for 120 Blessing bags would be a total of \$1,080.
