- **Mission/Abstract.** The Mission of the Bridgeport Pardons Assistance Project (BPAP)¹ is to combat poverty, from the first day of an ex-offender's release from prison, through a *Culture of Pardons:* public service, volunteerism, goodness, dedication, forgiveness, grace, discipline, faith, and family these are kinds of things an ex-offender needs to obtain a Pardon. Herein is an application for a \$5000 grant to cover direct stipends to clients.
- 2. Introduction. We are combating poverty in that we have opened the first pardons assistance office to cover all of Fairfield County (bpapct.org). The BPAP is important for the Fairfield County reentry community because it marks real on-the-ground change borrowed from enlightened criminal justice theory espoused at the State of Connecticut Department of Corrections and by the State of Connecticut Board of Pardons and Paroles (with which dept. we are working closely). Of course, not every ex-offender and family that applies for a Pardon will be granted one but great things can and will happen for all who engage the process. The point is create and engender a *Culture of Pardons* the more ex-offenders who are granted pardons, the more we will combat lives of poverty for <u>all</u> ex-offenders and their families.
- **3. Statement of Need.** In this application, we request \$5000 for direct stipends to BPAP clients these stipends will be utilized for pardons process readiness such as obtaining records, references, transportation, appropriate clothing, employment/career readiness, and related functions in the discretion of the trained BPAP volunteer, each stipend to be approved by the BPAP Director.
- 4. Objectives. The BPAP's objective is to bring professionalism and respect to a process at a time when our clients' have already been through the most difficult and dehumanizing periods of their lives. Our volunteers have been trained at the State of Connecticut Board of Pardons & Paroles. We have a consultant who has a Director-level position with a sister agency that has decade-long pardons center pedigree and experience. We seek funding to ensure that each and every client relationship, and its attendant application, will reflect pride and honor of a client and family that has turned its life around and is now striving for its highest, best usefulness to God and community.
- **5. Evaluations.** We will have a thorough orientation, training and evaluation program for staff, clients and application process, set up, operationalized and assisted by a sister agency that has decade-long pardons center experience.
- **Future Funding.** We expect that the majority of future funding will come from affluent Fairfield County church outreach committees and similar faith-based sources. We have had significant contact with these committees and are optimistic that we fit their missions.
- **7. Budget.** Submitted herewith. Please note its simplicity this is not a complex ministry.
- 8. Congregational Hospitality. The BPAP is part of a larger mission at the First Baptist Church of Bridgeport to welcome and offer a home to the reentry and recovery communities. We recognize it might be difficult to imagine in some churches not in ours! This plan has fully approved by both Senior Pastor Hopeton Scott and the full Congregation of The First Baptist Church of Bridgeport.
