A panel will select recipients for grants of up to \$5,000. Awards will be granted only to ministries of an American Baptist church in good standing with their Region. This is a change from previous grant cycles. We will no longer award grants to organizations affiliated with churches such as a cooperative group that includes non-ABC churches; applications must be submitted by an ABC church for work being done directly by that church.



Only one application per church will be considered within a 24-month period.

Grant funds may not be used to fund staff positions, rainy day funds, church benevolent funds, regular ongoing church operating expenses (i.e. utilities, insurance), repairs, or for capital improvements or repairs to facilities. Grant awards will be sent to the ABC church that is applying for the grant; checks will not be made payable to an individual or ministry.

- 2. What ministry or group will use these funds?
 - The funds will go to the First Baptist/Washington School Poverty Hunger/Enrichment Partnership Ministry. The church directs this project jointly through the mission/outreach branch of our Deacons and the Board of Christian Education. The Deacons mainly oversees the food portion of the offsite ministry (at Washington), while the Board of Christian Ed handles the onsite ministries (at First Baptist) and the enrichment activities. This began as a small ministry, but we are looking to expand it as in response to suggestions from the school and from within the church body.
- 3. Specifically, how do you plan to use the requested funds? Please include a <u>very brief and specific statement</u> on how the money will be spent. For example: to purchase school supplies for 100 elementary school children; to provide summer camp scholarships for 10 children from low-income families; purchase diapers and wipes for single mothers. We are targeting assisting a specific poverty population in partnership with their neighborhood elementary school, using a multi-faceted approach:

- --To purchase supplementary food staples that are culturally sensitive for distribution to approximately 50 families monthly;
- --To provide meals for approximately 60+ children at our church and some of their parents in conjunction with the Wednesday children's outreach programming.
- --To provide additional educational materials for the children at school, such as books for classroom or for children to take home.

- --To provide snacks for a targeted group of children during testing to help them be alert and do well (approximately 90 children).
- --To provide special opportunities for these children of poverty in the form of daycamp activities at school or camp and summer church camp scholarships for the children and/or their families. Starting daycamp numbers have been about 25, but we expect growth as the project is better known in the school.
- --To provide bus transportation to the various events, regardless of location, for those who need it.
- 4. How will the funds assist individuals battling poverty and its effects? What impact do you hope to make on the target group or community?

The funds accomplish several things. First, by coming alongside the local school, we are helping make sure the children have a chance at a good education by assisting with their basic needs, for a hungry child is unable to focus on learning. Our funds supplement the free and reduced lunches by helping cover food needs in the homes. Secondly by providing a place where children (and parents who choose to) can have a hot meal once a week during school, it means that is one less meal the parents have to provide at home out of their meagre funds. Thirdly the educational materials and opportunities for enrichment experiences mean that the children will have a chance at a better and more rounded education, which will then better enable them to later be able to get training and good jobs that could help lift them out of poverty.

It is our hope that as our work becomes known, inspire our people to deeper involvement while setting an example for other churches who might adopt other schools with needs. We are using this as a vehicle to build a positive reputation of our church in town, and especially to build healthy relationships with the recipients that may enable us to have other opportunities to engage with and assist them. We are discovering these things have created a positive relationship, and believe it may be an important step toward establishing a Spanish speaking service within our church to fill a gap we are discovering exists in our community.

- 5. Total cost of the project: estimated at \$14,000 per year
- 6. Amount being requested from the ABCUSA Matthew 25 Grant: \$5,000
- 7. List other funding source(s): Our church would provide about 65% of the project funding through private donations by individuals in the church and from the church budget as the expansion begins. In time we maybe able partner with other organizations for funding, or increase our own funding as people respond to the need and see the value of the partnership.

First Baptist/Washington School Poverty Hunger/Enrichment Partnership Ministry

Our church is seeking to significantly expand a multi-faceted ministry project aimed at helping families in poverty. The project targets a specific portion of our community's poverty families, including a number of immigrant families from Latin America who are trying to make new lives here in Fremont. A neighborhood elementary school near the church is the primary agency with whom we are partnering to identify needy families and address needs in tangible ways. This school includes many of our immigrant children as well as other neighborhood children, but some 90% of the children at this school receive free and reduced lunches. As we have developed that partnership, we have developed ministries in response to needs expressed by school administrators and by those in our church who observe children as they participate in the various ministries we provide. Below are brief descriptions of the specific parts of the project:

- 1) Because some of the food assistance in town is provided through agencies of which many of the Spanish speaking community are fearful or untrusting, and since that food is not culturally sensitive, we provide some monthly staples that fit the needs and desires of the people being served, delivering them to the school for distribution. The selection of products is guided by school officials who are in direct contact with the families. The goal of the help is to supplement the family's food supply at the end of the month.
- 2) During the school's standardized testing, we seek to provide healthy snacks for the children to help their performance and attentiveness. We began with a specific group of children, but are working to expand this assistance and to adapt to the changes in the school's testing program.
- 3) Because of limited opportunities for children in poverty, we initiated a new ministry idea this past summer by partnering with the school, the local Art Association and the Chess Club to provide a free Saturday day camp, with our church organizing the event and providing a nourishing hot lunch. (The other agencies we involved cover their own expenses for that event, but that may vary.)
- 4) School staff indicated educational supplies are sometimes needed. We plan to help purchase children's books for classroom use or to take home, just as other children who buy books at school book fairs do. While learning English, reading material is a critical educational tool.
- 5) Wednesday night programming at the church includes children's Bible studies and fun activities, and begins each week with a hot meal. A few parents also join us for the meal. We have also hosted a Spanish speaking Bible study to help us build healthy bridges with the Spanish speaking community, and include those families with their children in the meals and programming if they desire to participate.
- 6) We are seeking to provide opportunities at camp including: a) busing the children to our region camp for a day-camp style VBS; b) providing full scholarships for needy children we encounter through this project to attend church camp; c) providing a full scholarship to a selected family each year to attend family camp.

Note: For clarity, not all the families involved are Spanish speaking, and our program activities are available for others who might choose to attend, because we do not want to create more isolation for poverty families. The school has expressed great appreciation for the partnership, and has been an outstanding help in identifying families in need.

^{*(}Our programming budget for this ministry/grant application is from Sept. 2018 through Summer, 2019. The program will begin in September using funds gathered locally. Whenever the grant would arrive, it would supplement the funding to complete the project for the current school year and upcoming summer. Any costs above estimated budget will be funded by church or private donations. We try to expend grant monies in/measured allocation over the course of the project to ensure sustainability and dependability, rather than produce a one time "flash in the pan" situation. In the unlikely event that there is grant money left over at the end of the school year, that money would be used to fund additional children or families to attend camp and/or to fund an additional summer daycamp.)

- 3) To aid the school and families with some educational supplies (coordinated with school personnel) in order to help these poverty children have an opportunity for a good education and a better life.
- 4) To engage our congregation in ministry experiences, to build strong relationships with the staff and families of the school, and to impact that segment of our community in a way that engaged our congregation in ministry opportunities, some of which may lead to individuals from that population to connect with our church in other ways.
- 5) To set an example that may inspire other congregations to join in making a difference in the poverty areas of our community.
- 6) To do these ministries in such a way that we represent the message of the Gospel of Christ effectively and honorably to our community.
