A generous donor has given a sum of money through American Baptist Churches USA Office of the General Secretary, to be used for programs that address "housing, feeding. education and health with regard to the less fortunate." A panel will select recipients for grants of up to \$5,000. Awards will be granted only to ministries of an American Baptist church in good standing with their Region. This is a change from previous grant cycles. We will no longer award grants to organizations affiliated with churches such as a cooperative group that includes non-ABC churches; applications must be submitted by an ABC church for work being done directly by that church.



Only one application per church will be considered within a 24-month period. Because this change was made following the Fall 2016 cycle, recipients of a Spring 2016 grant are eligible to apply.

Grant funds may not be used to fund staff positions, rainy day funds, church benevolent funds, regular ongoing church operating expenses (i.e. utilities, insurance), repairs, or for capital improvements to facilities. Grant awards will be sent to the ABC church that is applying for the grant; checks will not be made payable to an individual or ministry.

- neals and a snack to elementary school students on days when schools are closed and their free or reduced meals are not available.

These elementary school students experience food insecurity for the 13 days during the school calendar when school is closed for holidays or teacher in-service training. First Baptist would like to fill this gap by providing two breakfasts, two entrees and two healthy snacks for each of these 13 days. Poor nutrition can result in a weaker immune system, shorter attention spans and lower academic achievement. Food is an essential building block and, in this case, is truly a blessing to a hungry child.
- 5. Total cost of the project: To fund 13 days for the coming school year would cost \$5,580.

- 6. Amount being requested from the ABCUSA Matthew 25 Grant: Our congregation would be most grateful for your consideration of this worthy outreach to our community. To fund all 13 days, we will require \$2,930 from the Matthew 25 Grant.
- 7. List other funding source(s): Our congregation has set a goal for outreach in the community and we "earmark" 10% of all revenue that we receive from a temporary contract with cell towers that are located on our property. This is currently \$325 per month. However, this funding source will only exist as long as the towers are located on our property. We anticipate this funding source only until November 2017. We also had a generous donation for this project in 2016 and we have \$450 of these funds left for the coming school year. We have also been gifted \$900 for this ministry through the DC Baptist Convention.

Question #3.

First Baptist Church of Camp Springs is requesting funds to provide elementary school students in our community with two nutritious breakfasts, lunches and a snack when schools are closed during the 2017/2018 school year.

During the 2016/2017 school year, our congregation partnered with Foot Foote Baptist Church working with the Blessings in a Backpack program. The 127 students that we served receive free or reduced meals during the week and Fort Foote Baptist Church provided meals for the weekend days. However, these children experienced food insecurity for the 13 days during the school year when school is closed for holidays or teacher in-service training. First Baptist Church was able to fill that gap.

Our menu included tuna meals, fruit, cereal, granola bars, mac & cheese single serve cups, fruit punch and hot coco packets. We assembled these bags on Thursday and then took them to the elementary school on Friday to assist the Fort Foote team in packing the students' backpacks. Each time, with careful shopping, these packages ran \$420 – \$435.

To fund each of the 13 days for the coming school year would cost \$5,580.

Our revenue source for the 2017/2018 school year is \$325 times 4 months from temporary cell tower contract or \$1,300. A \$900 grant from the DC Baptist Convention and a generous donation from 2016 of which there is \$450 left for the coming school year. These total \$2,650 leaving a shortfall of \$2,930. This is the amount we are seeking from the Matthew 25 Grant.
