### **ABCUSA MATTHEW 25 GRANT APPLICATION - 2017**

A generous donor has given a sum of money through American Baptist Churches USA Office of the General Secretary, to be used for programs that address "housing, feeding, education and health with regard to the less fortunate." A panel will select recipients for grants of up to \$5,000. Awards will be granted only to ministries of an American Baptist church in good standing with their Region. This is a change from previous grant cycles. We will no longer award grants to organizations affiliated with churches such as a cooperative group that includes non-ABC churches; applications must be submitted by an ABC church for work being done directly by that church.



Only one application per church will be considered within a 24-month period. Because this change was made following the Fall 2016 cycle, recipients of a Spring 2016 grant are eligible to apply.

Grant funds may not be used to fund staff positions, rainy day funds, church benevolent funds, regular ongoing church operating expenses (i.e. utilities, insurance), repairs, or for capital improvements to facilities. Grant awards will be sent to the ABC church that is applying for the grant; checks will not be made payable to an individual or ministry.

### How will the funds assist individuals battling poverty and its effects? What impact do you hope to make on the target community?

First Baptist Church in Jamaica Plain is a small but growing urban, multi-cultural, intergenerational, welcoming and affirming congregation. We are located in the heart of a vibrant, diverse Boston neighborhood. Because of our central locale, many people enter our doors seeking assistance, both spiritual and physical. Despite the fact that our building burned in 2005 our economically varied congregation has continued to provide countless folks in immediate need with grocery cards, bus passes, and subway passes from our Communion Fund. We continue be amazed at the response we receive when the passes become available. Passes are distributed to homeless congregation members, residents of the South Street Affordable Housing Complex, and elderly neighbors living off a fixed income, who come asking for a little bit to help them make it through the month.

For the last four years, we have run a weekly lunch for seniors on Saturdays and a Wednesday night dinner which is often shared with indigent friends. In these programs (and with the food pantry run by our neighboring UU church) we feel we are able to assist with food needs for our community. It has been our experience, however, that it is much more difficult for our neighbors in poverty to have adequate access to transportation. Most do not have cars, and although Boston is known for our public transportation, it has increased in cost over the years. A trip on the subway or bus ranges from \$.85 to \$2.75 depending on the kind of ID one holds. When a person is trying to get from shelter to job, or from social service agency to social service agency, or from home to the hospital, these fares add up.

We would very much like to offer transportation assistance to those in our community who are often forced to make choices between which bills get paid, or between eating and going to the doctor. It is much cheaper per ride if a person has a "Charlie card" or refillable pass (2.25 versus 2.75 per ride on the train and 1.70 versus 2.00 for the bus). The pass we provide is plastic and reusable from month to month, giving the individual an opportunity for less costly rides in the future. We have just switched our program from giving only the \$55 monthly bus pass, to providing or filling someone's past card with a \$30 balance per month which works on the bus and train and won't expire at the end of the month. We will still fill the monthly Link Disability/Senior passes which are also \$30. With the help of the Matthew 25 grant, our church would be able to provide transportation for roughly 25 people every month. Our new system provides us with the opportunity to help more people and use our funds more fairly. Some of the folks who would benefit from this program include Darren, who will be able to visit his wife in the hospital and oversee her care as she heals from surgery. Ana, who can help her uncle get to and from the hospital as well as travel herself as she waits for her disability application. Tony and Cindy who can travel to and from their jobs as they save money and search for an apartment. This program continues to keep the church in contact with those most in need of our assistance.

Receiving this grant would allow us to use our limited communion funds for the other items that are necessary in life (food, medicine, shelter) while we provide a vital service—access to transport—to our neighbors who struggle day in and day out with the very painful reality of what it means when there is 'not enough.'
