Grant funds may not be used to fund staff positions, rainy day funds, church benevolent funds, regular ongoing church operating expenses (i.e. utilities, insurance), repairs, or for capital improvements or repairs to facilities. Grant awards will be sent to the ABC church that is applying for the grant; checks will not be made payable to an individual or ministry.

When determining Grants awards, the following criteria will be considered: whether the church is in good standing within the region; whether the church contributes to United Mission; number of and amounts of previous Matthew 25 Grants received; sustainability of ministry beyond Matthew 25 Grant funding; description of ministry and needs addressed by funding; and the budget submitted along with this application.

Checks will be made payable to the church. Checks will not be made to an individual or ministry.

Explanation for Question 3:

The Matthew 25 Grant funds would be used to defray some of our costs to present local church conferences in South Berwick, Maine and Tuskegee, Alabama. Our intention is to present the concepts of Faith, Forgiveness and Reconciliation through our churches and for our communities over the next two years. Use of the funds would include conference speakers, and exchange opportunities for church leaders.

First Baptist Church of South Berwick, Maine is involved with a local, community initiative to develop Common Ground - a Sister City relationship with Tuskegee, Alabama. South Berwick, in its community discussions, is working to understand why race matters to a community that is approximately 97% white. It is now working in partnership with Tuskegee, a community that is approximately 96% black. Both communities are approximately the same in total population. We have already enjoyed some community exchanges through visiting delegations to and from each community and seek to continue building friendships and welcoming open discussions.

We have learned that faith is a part of our cultures – more so the South, than in the North. As the Pastor of First Baptist Church, we see that our churches (and denominations) have played historical roles as well. My discussions with pastors of both communities see that there is an important role that churches can play in teaching about faith, forgiveness and ultimately reconciliation. It is thought that this cultural growth is foundational to greater futures through positive, diverse interactions and relationships for our communities and our churches.

We hope to lead others in our faith communities in learning experiences as across the miles. Our hope is to offer conferences to promote Faith, Forgiveness and Reconciliation. We can build relationships, explore cultures as we teach these ideas.

As we seek to finalize our formats for interaction, we seek funding to provide the groundwork for learning as well as a forum that continues the conversations that have begun. We look forward to experiences that bring healing from that which has separated people for decades. The churches can be leaders in this movement.

Explanation for Question 4:

It is our hope that the influence of Churches can add to the relationships of people in both communities as we learn of the historical practices that have affected the community of Tuskegee – and how that differs from the experiences of South Berwick. Tuskegee offers a rich history leading up to the Civil Rights Movement. Tuskegee has struggled economically in recent decades and is attempting to rebuild for the future. South Berwick is learning and understanding (and teaching) history with relational examples and personal interactions with those who share rich experiences.

 of Christ throughout the world.
- Mission: "Together, Helping People Know, Live and Share the Good News."

Description of the Common Ground Project (from their Facebook page) The goal of the sister city project is to promote exchanges between two enthusiastic, proud communities - one in the north, one in the south; one predominantly Caucasian and one predominantly African American. The two communities are similar in size and both family-oriented. They both have proud histories. South Berwick is one of the oldest communities in Maine with a history in education and manufacturing. Tuskegee is widely known as the seat of the Civil Rights Movement and is the home of Tuskegee University and of the Tuskegee Airmen.

The mission of the project is "to afford the opportunity for the citizens of two communities, one predominately black and the other predominately white, to talk with each other, listen to each other and share with each other with the goal of broadening understanding between people."

A proclamation declaring local government support for these efforts was approved unanimously in early 2017 by both the Tuskegee City Council and the South Berwick Town Council.
