
### Our Mission & Goal

The mission of the DICP is: Because community makes all the difference, we will work to serve and strengthen ours.

The primary goal of the DICP is to empower our communities and support personal transformations, to ultimately create self-sustaining lifestyles for those who are most vulnerable. We equip our clients with the skills needed to break the cycle of poverty.

### The Community Served

Originally focused on Denver's Westside, today the DICP operates its programs from four main facilities and two sober living houses which draw clients from across the Denver-Metro area. During times of economic hardships, the need for our programs continues to grow. In 2008, approximately 10,000 people were served by our programs, compared to 2011, where approximately 25,000 people were served by our programs. Although most of our clients are Latino/a, due to the worsening economic climate and our expansion to other parts of the city, we are now serving a wide range of ethnicities. 100% of our clients are living at or below the federal poverty line, which in 2011 for a family of four was, \$22,350. Additionally, the programs offered by the DICP impact all generations, from infants to the elderly.



### The Problem & Our Work

The overarching problem that the DICP works to solve as that there is a growing number of working families living in poverty in Colorado who cannot meet their basic needs, therefore the cycle of poverty remains prevalent in our communities.

An age-old proverb suggests it is better to teach a man to fish than to give him a fish. At the Denver Inner City Parish (DICP), we do both by meeting clients' immediate needs as well as setting them on a path to self-sufficiency. Our approach is to first build relationships of trust with our clients with the goal to then empower them to change their lives. The DICP serves Denver's low-income families by offering 14 programs that focus on four key community needs: Hunger, Education, Building Community, and Health & Wellness. It is through our wrap - around approach that we are able to break this cycle of poverty, one client at a time.



### Our History

The Denver Inner City Parish was formed in 1960 by a group of Protestant churches. There was a time during the 1950s and 1960s when people, mostly Caucasians, were moving out of the inner cities and into the suburbs. Many churches left the inner cities during this time to follow their congregations. Unfortunately though, churches had played a critical role in offering services and programs for people living in poverty in the cities. Food banks, after school programs, seniors programs, and the like were often provided by the churches. As churches left the cities, there developed a gap in meeting the needs of the low-income families who remained in the cities. Out of this need a national Inner City Parish movement was led by a group of Protestant churches. The churches formed independent human service nonprofits to continue the work that they had once provided in the inner cities.


Although formed by two churches, the Denver Inner City Parish is a non-sectarian organization, and most of the programs are secular. The DICP continues to provide a bi-weekly open and affirming worship service that also has a hunger component built into it. Today the DICP serves approximately 25,000 people annually through 14 programs that focus on four community needs:

Hunger, Education, Health & Wellness, and Community Support.

## Financial Stewardship

The Denver Inner City Parish is committed to the proper stewardship of the financial resources to which it is entrusted. In 2012 the DICP had over 2,500 individual donors and 300 foundations, organizations and corporations that furthered the organization's mission through contributions of time, money, goods and services. The organization's budget for the 2012-13 fiscal year is \$2,104,157. The following graphs depict the sources of revenue and the breakdown of expenses.

Although the DICP operates debt free, like most nonprofits, cash flow is always a challenge for the DICP. To ensure financial stability during times of difficult cash flow the DICP built a \$300,000 reserve fund with the goal to grow the fund to six total months of operating expenses by the 2014-15 Fiscal Year. The reserve fund is governed by the Board Finance Committee which meets monthly.



### **DICP Board of Directors**

The Board of Directors is the governing board of the Denver Inner City Parish. They meet monthly to provide support to the Executive Director and assist in strategic decisions.

# MISSION STATEMENT: Because community makes all the difference, we will work to serve and strengthen ours.

Summer Day Camp at the Denver Inner City Parish is 2013's edition of a long-term program of the Parish. We have worked in Denver's low income community since 1960. Day camp includes nutrition programs (breakfast, lunch, and snack), recreation, arts and crafts, field trips, Vacation Bible School and other components. We will use a grant from the Matthew 25 American Baptist Fund to directly impact the 50 children enrolled and their families. We will be operating Summer Day Camp in our College View Recreation Center located at 2525 Decatur Street in Southwest Denver, enrolling children living near this community center. At College View, we serve primarily low income Hispanic families.

A grant from the Matthew 25 Fund will provide the educational component of Summer Day Camp. We will use \$2,500.00 to provide for reading projects, field trips to the library and museums, specialized instruction, and materials. As in many low income communities, the College View neighborhood of West Denver includes many children who do not read at grade level, and need extra help in the summer to avoid falling further behind. Summer Day Camp helps these children maintain and develop reading skills.

The Denver Inner City Parish operates a host of programs serving low income people, and our Summer Day Camp is an important part of this matrix. Families of Day Campers may, in times of need, access the Food Bank at the Parish to help get through particularly rough times. The Parish at College View provides extensive recreational activities: families can utilize our full-size gym, weight room, and outdoor facilities as well. Also at College View is one of two senior citizens programs operated by the Parish, which can be accessed by day camper grandparents. At other buildings also in low income West Denver communities, the Parish offers programs for ex-offenders, and our flagship program, La Academia School. The school enrolls junior and senior high school students, and helps prepare at risk youth to enter and succeed in college. La Academia can provide the next step for many Summer Day Camp Children.

The Parish is an unabashedly ecumenical program. We are funded in part by mainline congregations and by individuals and groups within theses congregations. Calvary Baptist Church here in Denver has been a mainstay of the Parish for many years - in particular, the women of Calvary have sponsored children in Summer Day Camp for 15 years. Summer Day Campers participate in Vacation Bible School at mainline churches every year: this year we'll be with First Plymouth U.C.C, and University Park United Methodist Church.

With important financial support from the Matthew 25 Fund, the Parish will again be able to offer a safe and quality program for low income kids aged 6-11. With the emphasis on reading that the Matthew 25 Fund will provide, we will directly impact the lives of 50 needy children.

They have a 52-year history of working with low-income children and the teens that graduate from their academy go on to college and really build new lives for themselves. The Denver Inner City Parish is truly shining Christ's light brightly and boldly in Denver. Our city would not be the same without their ministries and presence.
