The mission of Caring Ministries of Morgan County, Inc. shall be to provide assistance to people that are in need with the goal of enabling them to get through difficult times and become self-sufficient with the ability to meet their own needs.

The requested funds will be utilized in our pantry program that provides emergency food every 6 weeks to families and individuals. All clients that utilize our services in both locations are provided enough food for 7-10 days with a general value of \$150.00. We evaluate our families each time that they come to the pantry, assessing changes in status, providing information and referrals, (food stamps, jobs, budget classes). Recipes are given out as to how to stretch the food or make meals that are interesting utilizing the general food we provide.

4. How will the funds assist individuals battling poverty and its effects?

Caring Ministries works to evaluate the whole issue and not just throw food at the situation and hope it gets better. Last year CMMC fed 1744 families and 1086 singles in our two pantries, this equates to 235 clients per month which means we are feeding 10 percent of our county. We also work to educate the county/residents on the growing needs of community, how high rent, lack of transportation and high utility costs leads to high numbers of people unable to make ends meet so more demands for food. Partnering with a family center that teaches budgeting and referring families to these classes, helps families and individuals understand how to make food stamps, pantry and other revenue stretch as far as possible. Our partnership with all the ministerial alliances within Morgan County helps us reach those in need as well better utilize our limited resources.
