#### FINANCIAL STATEMENT FOR HOMELESS SHELTER

Attached is the estimate for the entire rewiring of the building, he has made several recommendations in the description and we are taking his suggestions so the full cost of the rewiring is \$4031

#### **PROPOSAL**

The money requested would be used to rewire an existing building that we are planning to use as an emergency shelter. The building has not been purchased yet, but we are trusting that we will win the bid for it at an auction on September 18<sup>th</sup>. The first update that will be required is to have the building rewired. The attached budget would be the cost of that first stage only. We are confident that the other stages will be paid for as they come along. God knows that there is a great need for this shelter in Greene County. Agencies are paying \$80 to \$90 a night for motel rooms, which is depleting their emergency shelter funds very rapidly. The nearest shelters are 25 miles away, causing a real hardship on families who have children in school, and individuals who have jobs locally, or do not have transportation. Clients at this time are being referred by Catholic Charities, Salvation Army, and Greene County Human Services. According to Amy Switalski, Greene County Director of Housing and Family Resources, in the past year 16 individuals were put up in local hotels, 19 were denied services due to no vacancies at local hotels or shelters, and 19 people were sent to shelters outside of Greene County. These are unduplicated numbers, which means that a total of 54 people came to us needing emergency shelter. Audrey Quinn with Salvation Army reports that they had 31 cases for a total of 38 nights that included 45 adults and 10 children in their last Fiscal year. As American Baptists, we take pride in working ecumenically -- this is an opportunity to bring local churches and agencies together for the common good. Local churches would provide the volunteers to staff the shelter in the evenings, giving them the opportunity to minister to these families and individuals with the saving knowledge of Jesus Christ, and let them know that He can and does make a difference.

As you read this proposal, you may hesitate to entrust GWCO with this funding because the building has not yet been secured. You may also not be familiar with the WWJD Christian Center. Our reputation is excellent, and transforming buildings into ministries is not a new adventure for us. The 2013 Jitsuo Morikawa Evangelism Award was presented to Cathie Carpenter in recognition of her holistic approach to evangelism, through which God is working to transform the local community of Waynesburg. The GWCO most recently purchased a piece of property with a church building, attached parsonage, and a detached fellowship hall. The church building now houses the congregation of WWJD Christian Center, the parsonage is home to our children's ministries director, and the fellowship hall now provides a place for the children's ministries. Six years ago an old bar was purchased and transformed into a place where our youth ministries currently take place. God has blessed and expanded us in ways we never thought possible and we believe that He is leading again in this endeavor.
