#### Companis - Matthew 25 American Baptist Churches USA grant application

With \$5,000 from the American Baptist Churches USA Matthew 25 Grant, Companis will ensure that a dedicated and caring Companis professional (Companis Worker) will continue to provide food and shelter to homeless women and children of Seattle in the 2013-2014 year.

That may sound like an unrealistic claim – how can we do all that with \$5,000? But that's how Companis works, and that's why we're meeting our mission as we head toward our 20<sup>th</sup> year of helping more than 100 nonprofit agencies thrive and survive, providing internal capacity when they need to grow but can't afford it, or suddenly are faced with a budgetary setback.

We do this by leveraging what struggling nonprofit agencies can afford to pay toward a salary (often nothing or very little) with donor dollars, and importantly, providing significant, nurturing support for workers undertaking the important work of feeding, clothing and sheltering the neediest – providing a way off the streets and back into homes, jobs and meaningful community for some of the most vulnerable populations in Seattle. In 2012, 65 Companis Workers served 40 nonprofit agencies and ministries and provided a value of \$1.6 million.

Companis has a track record of success. Since our founding in 1994 as a ministry of Seattle First Baptist Church (SFBC) and with seed money from ABC USA World Relief Committee, we've made a difference in the lives of the poor, the suffering and the sick. Companis, although now a separate 501(c)3, remains in partnership with SFBC, which supplies free office space and contributes an additional \$42,000 to our annual budget. The Rev. Craig Darling, Pastor for Vocation & Call at Seattle First Baptist, serves as Executive Director of Companis.

Indeed, Companis' partnership with Mary's Place, Seattle's only overnight shelter for homeless women and children, started with a call from Seattle First Baptist Church. The church was aware of a homeless shelter for women in desperate need of help. Could Companis provide any?

Mary's Place Director Marty Hartman was frustrated seeing her clients return to dangerous streets at night. When a hoped-for city grant didn't come through just as she was expanding the day shelter to overnight use, she put her hopes in Companis. Companis responded quickly with the placements of workers Alyson Moon, MSW, and Betty Reid, a retiree and member of SFBC. In particular, Companis Workers are helping the shelter's growing population of homeless elderly women, a vulnerable group hit hard by the recession and in need of specialized services to rebuild their lives. (And because this need has been so great in the Seattle area, Companis also placed two other workers, another MSW and a volunteer coordinator, at a day shelter for homeless women in 2012-13.) Our funding commitments expire in July, and we are raising funds so that we can continue to help meet the need.

Our program is a great match with the Matthew 25 Grant because our workers are directly involved in services that offer the poor a helping hand from the streets and into stable lives, services that won't continue at current levels if Companis cannot meet this need. Your \$5,000 grant would extend Companis dollars already pledged and to-be-pledged by our generous individual donors. We also are seeking corporate underwriting for this project, and believe this grant will stimulate corporate donors by demonstrating significant progress towards our goal of raising \$36,800 to continue the MSW position.

Money talks, but so do heart and soul. With our commitment to "action and reflection," Companis works to create an ever-growing community of those who work for the less fortunate. Our workers attend twice-monthly, facilitated meetings that serve to inspire and nurture, attend several day-long and multi-day retreats over the course of the year, and are intentionally connected to community resources and experts in areas pertinent to their placements. As fellowship and resilience develops over the course of the placement year, our workers are enabled to find resources and to sustain the compassion necessary to engage with often difficult populations. Betty calls her service at Mary's Place "a dream come true." For Alyson, new to Seattle, it's a way to relaunch a career. For the women of Mary's Place, Betty and Alyson are gifts beyond measure. With your help, Companis will continue to give this gift.

## **Companis Mission Statement**

Companis fills staffing gaps of nonprofit agencies with professional volunteer and community workers who provide medical care, food, shelter, education and more to the needlest among us. Companis is often called "Seattle's Peace Corps," because we strengthen agency partners while creating a corps of citizens working for justice among our neighbors.
