

ABCUSA MATTHEW 25 GRANT APPLICATION

A generous donor has given a sum of money through American Baptist Churches USA to be used for programs that address "housing, feeding, education and health with regard to the less fortunate." A panel will select recipients for grants of up to \$5,000 largely based on the degree to which the funds will be used to directly assist persons in poverty. Ministries must be in relationship with American Baptist Churches USA to be eligible to apply, and only one application per church or ministry will be considered per year. Grant funds may not be used to fund staff positions.

I would like to submit this request for consideration to receive a grant from the Matthew 25 Grant fund. I am a volunteer pastor in Cheyenne, Wyoming where I serve our local homeless shelter call the Comea House. I hold church services every Sunday morning and have for about 7 years. We have unofficially dubbed it Comea House Church. Our services are held in the dining room of the facility. I am also basically on call 24/7 if there are any needs any other time, unfortunately because I am a volunteer pastor, I still have to have a full time job to meet the financial needs of my family.

In the past seven years there have many times when I felt that some who came to me for help deserved to receive assistance. Sometimes it was to get to another state where a job was waiting for them if they could get there, other times after trying to get a job in Cheyenne and not finding one, they were trying to get home where they could stay with family. Currently, I have a young lady who is trying to get home, she followed the work, but it ended and needs to get home, her mom is in the hospital and she had kids which her mom was watching. Her grandfather is taking care of them for the time being until she can get home. Other folks just need help with medicine.

I'd like to say we have a budget but then, that would mean that we have money. Most of what I do for church comes out of my own pocket, my church Cheyenne First Baptist (A member of American Baptist Church of the Rocky Mountains), has helped with purchasing bibles and other items for the residents, but there is no money for anything else. We have no expenses as far as rental, utilities, etc. because we meet at the facility.

I am seeking to get around \$2,000 or whatever I can, anything would help in the endeavor, the funds would be managed through First Baptist and I will put together a committee to consider all requests and verify what they have told me they need the money for. Having been the head of our Deacon Board a few years ago I dealt with our benevolence fund and was able to determine those who really needed it and how much. Even now I am very particular about anyone I send to church to request help, because they really don't seem to be sincere in what they are asking for.

You ask for a Mission Statement, I say the mission of the Comea House church is to encourage the homeless and those in need by providing them with hope for a brighter future through Jesus Christ our Lord.

Thank you for your time and consideration, I am glad that someone has stepped up to help meet the needs of so many. God Bless all of you.
