Lake Avenue Baptist Church has been directly involved in ministry with refugees from Burma since the fall of 2006. Over 1000 refugees from Burma now live in Rochester, NY. Our Refugee Outreach provides direct assistance to these individuals and families as they deal with health problems, housing issues, education concerns, and seek to find and keep employment. Our assistance involves the whole range of concerns of these individuals and families who arrived as refugees with only what they could carry in their bags and are now trying to build new lives in the United States. We seek to help them gain the skills they need to move out of poverty and become contributing members of American society.

Our Refugee Outreach focuses on connecting people with resources, helping people find their way through the complicated bureaucracies of medical systems, social services, and the Rochester City Schools, and advocating for cultural understanding and fair treatment. Our Refugee Outreach Coordinator, Hkadin Lee, and fulltime volunteer, Liz Ewell, along with many more volunteers, spend over 100 hours a week in direct service with refugees from Burma explaining paperwork, filling out forms, making phone calls, sending emails, making home visits, and providing transportation. They help sort through problems with landlords and try to help families have decent, affordable housing. They assist those with health issues by setting up medical appointments, arranging transportation and interpreting services, and when necessary attending as supportive advocates. They intervene when problems arise with employers and give leads on new and better-paying jobs. They make sure that food stamp and welfare applications are completed correctly so that families have the basics of food and shelter.

Education is a vital concern for all of these refugees. Everyone needs to learn English, and they want to become American citizens. We have 15-20 volunteers providing weekly tutoring in English for adults. We are very excited that more than 20 young people and adults are now going to college and that many of the younger children are testing out of ESOL classes as they become fluent in English. But we are very concerned about the 12-15 young people who are aging out of public high school without a high school diploma or the knowledge of English to pass the GED. In 2013 we have begun a new initiative to "develop and implement a program aimed at engaging, empowering and supporting youth success in school along with their parents." We are focusing on education in a more intentional way, recognizing how vital this is if these youth and their families are going to move out of poverty.

Our Refugee Outreach work is being done in partnership with other groups and agencies in the Rochester community. We work with Catholic Family Center (our resettlement agency), the Catholic diocese's refugee ministry called Mary's Place, and multiple other agencies and churches. We have received great support from other ABC churches and our region, ABC Rochester Genesee Region. Within our ethnic Burmese communities (Karen, Chin, Karenni, Kachin, and other Burmese) there are strong leaders who are an important part of our ministry. They are developing the knowledge and skills to help their own communities and work alongside American volunteers to do this work.
