Karen transportation proposal (draft)

There are 8,000 ethnic Karen people living in St Paul, MN. It is the largest concentration of Karen in the U. S. Almost all have arrived here as refugees, forced to leave Burma by a brutal dictatorship. Many have only recently arrived (within the last 5 years).

They face numerous challenges in adapting to life in Minnesota.

One of the biggest challenges is transportation. It is often difficult to shop and transport groceries from the store to the places they live. Large families require many bags of food and rice. For many without adequate transportation this is difficult.

We are proposing a simple shuttle service from homes to nearby Asian grocery stores. Drivers would be Karen speaking persons. At first there would be two "runs" every weekday evening and two on Saturday. This service would operate two times a month.

Group A (Up to ten people) would be picked up from their apartments at 6:00 pm and brought to a store.

Group B (from a different apartment complex) would be picked up at 6:30 and brought to the store.

At 7:15 Group A would be picked up at the store and brought home.

At 7:45 Group B would picked up at the store and brought home.

The fare would be \$2.00/person/round trip. Reservations would be taken at least two days in advance of the shopping. If seats were available a person may able to participate at the time of the "run" on a standby basis.

First Baptist Church of Saint Paul would make 2 vans available for this service. FBC would also be the insurance carrier for this ministry.

There would be a person who would be the coordinator, receiving calls and confirming reservations.

Each apartment complex (where concentrations of Karen live) would have a contact captain.
