Our organizational vision is to serve as a catalyst in bringing organizations and groups together for the purpose of forming partnerships and alliances, so that we can leverage resources in addressing more effectively the needs of our community.

As the non-profit, emancipation arm of First Institutional Baptist Church, the mission of FIBCO Family Services is to meet the community's needs by providing resources and education to help individuals and families become self-sustaining. In order to achieve that mission, we have to address the issue of poverty that plagues so many. Currently, we are addressing the needs of our community's impoverished by providing meals through our food pantry, clothes through our clothing distribution center, and housing through our affordable housing program. In addition, we provide support services to our African refugee population, many of whom also live in poverty. While these programs address the emergency needs of individuals and families, we recognize that they are not long-term solutions to their struggle with poverty.

As indicated by the United Nations' Department of Economic Security and Affairs, one of the root causes of poverty is unemployment. Even as jobs are created, those living in poverty have to have the skills and means to respond to available job opportunities. In an effort to address these demands, FIBCO has partnered with City of Phoenix to offer a workforce access point that enables the community to have access to computers in our facility. Currently, the computers in our lab are very out-of-date and do not function very well. As a result, it has limited our capacity to meet our community's needs.

With the support of the American Baptist Churches USA Matthew 25 Grant, we would be able to expand the services that we provide. Our access point would evolve into the FIBCO College & Career Center, which would be dedicated to helping members of our community, especially those that are impoverished and unemployed, gain the skills they need to enter the workforce.

The funding we would receive would go toward obtaining new, functioning computers for the Center. The computers would be used to provide job skills training in topics such as keyboarding and basic computer software. As the program advances, more advanced skills can be offered in subjects like graphic design and business plan production. We will also provide workshops in completing job applications, résumé building, interviewing, and dressing professionally. Additionally, the computers would be used to assist individuals in completing financial aid forms and gaining entrance into post-secondary education institutions and vocational programs. The Center will also help members of our African refugee population learn English as a second language and offer native English speakers the opportunity to learn Spanish as a second language in order to enhance their ability to participate and be competitive in the local job market.

A small portion of the funding would also be used to market the program to the public and the remainder would go toward purchasing ink, paper, a bulletin board for posting job openings, a scholarship file cabinet, and software for the computers. As an incentive to visit the Career Center and attend workshops regularly, we will also use some of the Mathew 25 funding to purchase bus passes for participants in need of transportation assistance to visit the Center and look for jobs.

Through the Matthew 25 Grant, we will provide impoverished peoples with free access to computers, guidance, education, and job skills that can prepare them for the workforce. This access will enable them to become self-sustaining and will have a long-term impact on their overall well-being.
