Grant funds may not be used to fund staff positions. Grant awards will be sent to the ABC church or organization, checks will not be made payable to an individual or ministry.

Matthew 25 Request

The members of Lake Street Church (LSC) are committed to looking deeply together for ways to live our commitment to fulfill the biblical imperative to care for our neighbors (Matthew 25). Our Peace and Justice Committee (P&J) helps the congregation find ways to change the lives of those who suffer hunger, homelessness and other challenges of poverty and inequality. Our members have a long history of volunteering and contributing time, money, food, clothing and services. But as our ministries expand to meet the multiple needs identified, we look to the ABC Matthew 25 Fund to augment our resources to do this work.

Since 1984, LSC has been a driving force and the host site for Hilda's Place, now Evanston's main homeless shelter, operating from our church annex basement. While many services have now been built into the shelter's program through our external partner, Connections (an Evanston social service agency for the homeless), our P&J group, Sustenance Connection, continues to offer hospitality, and build personal relationships with our guests by hosting two dinners monthly, each feeding 35 to 45 people. Members bring prepared dishes and create some of the meal in our community kitchen, while P&J subsidizes main dishes and drinks. The priceless opportunity for our members to join the Hilda's Place residents for these meals provides invaluable food for the soul for all participants.

Another hunger-targeted effort is our sandwich-making project in which we meet monthly in LSC's community kitchen to make, pack and deliver sandwiches and other food items for distribution on the streets of under-served neighborhoods of Chicago through our partners from the Night Ministry.

We also have a growing ministry at Lake Street that embraces the struggle of our immigrant brothers and sisters in an era where delayed reform creates inhumane situations. One of our projects is to accompany immigrants who find themselves in a limbo between inhumanely scheduled court dates. They are turned out on the streets from detention with only the clothes on their back at the time of incarceration, lacking sufficient clothing and basic toiletries. We pick them up at court and help them find their way to their families across the country or to temporary housing locally. An essential element is our providing backpacks of basic clothing (including critical winter-wear) and personal care items to sustain them through that difficult transition period.

Our immigration ministry has taken up a new service project critically needed to support immigrant families in the process of seeking asylum. We work with the leading city- and regional-wide immigrant relief organizations to provide emergency shelter in the full scale apartment in our church building. Previously a home for the sexton, the space has been underused with no resident sexton in years. We are in the process of reconstituting it as a comfortable space for individuals or families while their cases get established in the courts and the mainstay housing providers can identify and obtain long-term placement. We are asking for Matthew 25 funds to help obtain some of the food, clothing and personal care items they need as well as for items needed to continue to make the space into a comfortable, welcoming temporary home. Our congregation does the rest by embracing and accompanying the resident family, making them part of our LSC community. This service is critically needed now because drastic cuts in our Illinois budget have decimated the government resources that used to provide shelter for immigrant families in crisis.
