BGM EC 626 DEVOTIONS

ABCUSA President Josué Gómez-Menéndez welcomed ABCUSA President Elect Karen Podsiadly and Vice President Elect Jim Wolfe.

Jose Manuel Magana lit the Christ Candle in recognition of Christ's presence and led the committee in prayer.

BGM EC 627 CALL TO ORDER

ABCUSA President Josué Gómez-Menéndez called the meeting to order.

BGM EC 628 CONSENT AGENDA

The agenda items dated September 12-14, 2019 and the minutes of the June 17-18, 2019 meeting of the Executive Committee, held in Virginia Beach, VA. were approved with no objections.

BGM EC 629 REPORT OF THE GENERAL SECRETARY

The theme for the summer has been "bearing witness to Christ in a broken world." Lee signed on to two significant ecumenical letters. (1) The Evangelical Table of the National Association of Evangelicals regarding the inhumane conditions for children in custody of the federal government and advocates for specific recommendations for a more just and humane treatment of people attempting to enter our country. (2) Church World Alliance calling for the strengthening of the U. S. Refugee Admissions Program in cooperation with religious organizations.

At the Baptist World Alliance (BWA) meetings held July 8-12, 2019 in Nassau, Bahamas, Lee composed the original draft of the BWA Resolution on Current Manifestations of Religious Intolerance and Religiously-Motivated Violence. It was the first BWA statement opposing anti-Semitism in several decades. A Resolution on Recognizing and Affirming the Calling of Women in the Church, was also passed.

Responsive Action by Lee:

<u>Political and Social Turmoil in Puerto Rico</u> - In response to the political and social turmoil in Puerto Rico, Lee encouraged the ABCUSA regions to express support for their brothers and sisters, and for the welfare of the island.

<u>Against Christian Nationalism</u> - Lee endorsed the Baptist Joint Committee's *Christians Against Christian Nationalism* statement.

<u>Plight of Kachin Baptists in Myanmar</u> - In cooperation with the Burmese Refugee Commission Lee corresponded with officials of the United Nations, US Government and Myanmar's leadership in support of Rev. Dr. Hkalam Samson. On September 4, an appeal was issued to the churches to offer prayers for safety before Dr. Samson's court hearing. The case was dropped. <u>Poor in American Society</u> - Lee added his name to the ecumenical *Circle of Protection* campaign, which seeks to encourage all presidential candidates to "produce a three-minute video telling the American people what you would do as president to offer help and opportunity to hungry and poor people in the United States and around the world."

Initiatives:

<u>Fresh Expressions</u> - On August 23, Mission Northwest Executive Minister Charles Revis and Lee visited Junction Church's Dinner Church Outreach in West Seattle, Washington, who hosted 53 community residents at the meal.

Golden Rule 2020 – Partnering with NICD, Marsha Scipio is spearheading an initiative with Christian leaders across the theological and political spectrum to come together on Sunday, November 3, 2019, a year before the 2020 elections, to pray for healing of our country and to emphasize the need to apply Jesus' teachings to our current politics.

<u>Hopevale Commemoration</u>: In cooperation with the Convention of Philippine Baptist Churches, International Ministries, the American Baptist Historical Society, Green Lake Conference Center, and the Office of the General Secretary is launching the Hopevale Commemoration in December 2019. The Hopevale section of the abc-usa.org web site is under construction, and will feature articles, bulletin inserts, videos and photos related to the Hopevale story. A mass mailing with a bulletin board poster will be sent to churches in November 2019.

<u>Mission Table</u> – Jeff Woods will be in charge of implementing the Mission Table with the board.

BGM EC 630 588 PROPERTY UPDATE

Currently remaining in the building is the Office of the General Secretary (OGS), American Baptist Foundation (ABF) and Kay Eland of American Baptist Historical Society (ABHS). Presser moved out last month. The plan is to auction off furniture and fixtures left in the building after everyone has moved out. The auction items are estimated to be \$500,000 and includes the sale of the stairs materials, copper pipes, and mechanical systems. Items being auctioned will need to be negotiated with the buyer and demolition manager by December 2019. The buyer received approval by the township to build on the property. March 2, 2020 is the latest close date and at that time the first payment will be received in the amount of \$8,250,000. ABCUSA owns 35% of that amount and then ABCUSA will receive installments for ten years. After the ten year installments \$9.75 million will be paid to ABCUSA. Before the demolishing of the building in March of 2020, Environmental issues amounting to \$500,000 will need completing.

BGM EC 631 ROBLEE BUILDING UPDATE

The move date is scheduled for October 17. All of the storage and cabinet cleaning out will be completed by the end of September. The latest projected cost of the AV equipment is much lower than previously expected as more realistic options have been discussed with the contractor for the needs of the office.

BGM EC 632 EMPLOYEE HANDBOOK

The BGM Executive Committee will review and discuss using Google Docs. After the manual is reviewed by the BGM Executive Committee, the next step would be for David Knipel, Esq. to review and then share at the November Board meeting. The Personnel Manual should be reviewed and revised each Biennial.

BGM EC 633 PERSONNEL TRANSITIONS

Annie Marcucci retired June 30, 2019 and Ken Marsenburg's last day of employment is September 30, 2019. Evon Moody's position is secure and does not change. Ken provided a list of his duties which will be helpful for the future new fundraiser. During 2020 there will be a search for a new ABCUSA Fundraiser. The new fundraiser position would be an entry level grant writer working for Tina (Turner) Kiernan. In the meantime the plan is to work with ABF as a partner. The fundraiser position would then work in addition to United Mission. Rebecca Driscoll is working on a three term grant while morphing her work as Minister of Environmental Justice. There is no need at this time for any more staff transitions or changes.

BGM EC 634 BIENNIAL MISSION SUMMIT 2019 AND OTABL EVALUATION Some repeat comments from the evaluation:

- (1) Worship was too long.
- (2) Worship time became a time for partner commercials not worship.
- (3) Lacked a presence of women clergy preaching/speaking.
- (4) Presentations and recognitions by the partners did not feel like worship.
- (5) Like the themes and variety of the tracks and the ability to choose which ones to attend.
- (6) Wanted more variety in meals and food options.
- (7) Childcare was inadequate.
- (8) Too much distance between the hotels and convention center.

Note: The Biennial Academy got high marks. Meals brought down the numbers.

Some thoughts for planning the Biennial Mission Summit 2021 in Puerto Rico:

- (1) Include the partners without commercials.
- (2) Jeremy was superb!
- (3) Lee was proud of the youth track despite internal problems. (Almost 100 kids)
- (4) Lee believed that God wanted us in VA Beach so that we could be a witness to them.
- (5) Judy regrets not spending more time praying for VA Beach and for not inviting the Mayor.
- (6) Move business session to Saturday (Many pastors need to preach on Sunday)
- (7) Worship needs to express the diversity of the denomination
- (8) The EXPERIENCE is important.

OTABL had less numbers than in past years. Lee discussed some of the internal problems that led to difficulties in planning.

BGM EC 635 COORDINATING FOR FUTURE BIENNIAL MISSION SUMMITS Lee presented two possible options in handling Biennial Mission Summit (BMS) coordinating.

The first option would have three people involved. (1) Professionals for non-profits that do conference planning and hire a part-time staff coordinator. (2) Have the local region coordinate hotels and logistics for on-site. (3) Have the General Secretary plan the leaders and speakers and be responsible for the Biennial.

The second option would be to hire an outside agency to handle the Biennial coordinating with conference center and hotels.

It was noted that in past Biennials the Biennial Planning Team is not involved with the Staff

Advisory Group (SAG) causing the Planning Team's original work to get lost and ideas of the Planning Team are not implemented.

A venue for 2023 needs to be selected. The next location for the Biennial is the Midwest.

One of the concerns of the NEC is "why is staff putting out so much work for so few people; as well as, the cost involved." Need to answer in 2021 why would the partners want to come?

Lee suggested that the BMS in 2023 be held at a large hotel to have cheaper price points and to save money and work since a hotel comes with an event planner.

A suggestion was made that the Interim General Secretary serve as the Biennial Coordinator for BMS 2021. Josue would serve as the contact person until IGS begins in January 2020. More discussion was tabled until the next day.

BGM EC 636 ROBLEE FUND

At the June 2019 Board of General Ministries (BGM) meeting in Virginia Beach, the board voted to politely and lovingly decline the request from International Ministries (IM) to replenish the Roblee Fund with monies received from the sale of the Mission Center. IM has not yet been informed of this decision as Lee had wanted to speak with Sharon Koh in person at the ABC of the Rocky Mountain Region Annual Gathering, as they are both speaking at that event. Lee plans to ask for a compromise to offer something since the board voted not to replenish the fund.

BGM EC 637 YEAR TO DATE FINANCIALS

Overall Financials Excluding Biennial

Overall the year-to-date financials show a net loss of \$378,000. The loss was primarily due to the Development Office which had a loss of \$152,000, and Information Technology which had a loss of \$152,000.

Revenue compared to last year is up \$192,000. The primary reason is due to Denominational Emphasis which had funds released from restriction.

Expenses are higher this year as compared to the previous year by \$443,000. The primary reason for the increase in expenses was due to the funds released from the restriction in the Denominational Emphasis department and Information Technology, which was only part of ABCUSA for six months in 2018.

Biennial Mission Summit

The Biennial Mission Summit had a loss of \$164,000. Hotel, meal, and shuttle costs were the primary reasons for the loss. There were not enough meals in each of the meeting rooms to offset the cost. Also, running the shuttles all day each day between the hotels and conference center created some of that loss.

American Baptist Mission Support

Total United Mission (UM) is down 2.9% from the previous year; however, general UM distributed to ABCUSA is down by 11%. World Mission Offering (WMO) is down 13.16%.

Retired Ministers and Missionaries Offering (RMMO) is down 6.01% and Region Offering (RO) is down 12.34%

BGM EC 639 UNITED MISSION (UM)

Judy Fackenthal made a motion and seconded by Jose Manuel Magana to recommend to the ABCUSA Finance Committee to restructure the national portion of UM line 12 down, Common Services (see appendix 1) be combined as one line item and cutting line 14, ABHMS Personnel Services, in half and the remainder of the section would then go to OGS.

VOTED: Motion Approved

At the November board meeting the board will need to vote on the use of the funds in 2020.

Paul Higgins made a motion and seconded by Dean Parker to authorize Alan Musoke to prepare a budget to bring to the November 2019 BGM Meeting to use a portion of the 2020 building sale proceeds for the 2020 budget.

BGM EC 640 EXECUTIVE SESSION

BGM EC 641 KACHIN AMERICAN BAPTIST ASSOCIATION AMO REQUEST Paul Higgins made a motion and seconded by Dean Parker to accept the AMO request for the Kachin American Baptist Association to become an Associated Ministry Organization (AMO).

VOTED: Motion Approved

Lee will make arrangements for the leaders of the Association to appear at the November BGM Meeting.

BGM EC 642 NICD TRAINING REQUEST OF BELOVED COMMUNITY

At the June 2019 board meeting in Virginia Beach, Judith Christiansen, on behalf of the Beloved Community Action Group, recommended to the BGM Executive Committee to add to their agenda in the September meeting a discussion about including an NICD workshop in the November BGM meeting. This would include deciding on one of two options to add to the November agenda; a two hour module training or a train the trainer training of four hours. Also, a standing agenda item at all BGM meetings that would include a short training or video on civility.

The Golden Rule 2020 initiative is currently underway and since there is not a lot of time to have a training at the November 2019 BGM meeting it seems best to hold off on the training. The Executive Committee would also like a list of the costs to decide if this is something that the board could provide at the June 2020 BGM meeting.
