**For the Year Ended April 30, 2020**

**Overall**

The year-to-date financials show a net loss of (\$3.3K) without the Biennial and a net loss of (\$3.7K) including the Biennial. These amounts were determined using the Consolidated Statement of Revenues and Expenses without the Biennial.

Net revenue compared to last year is down (\$384K). Expenses as compared to last year are lower by (\$527K). The decrease in expense and revenue in 2020 is primarily due to ABCUSA Departments and Denominational Emphasis.

**Payroll Protection Program**

We did secure a loan from the Payroll Protection Program (PPP) of \$619,959.06 for ABCUSA, \$58,295.54 for American Baptist Women Ministries, and \$66,547.07 for ABHS. The total amount received is \$744,801.67 for the three organizations. We will realize the loan of \$619,959.06 as income once the loan forgiveness requirements are satisfied. Current guidelines require spending at least 60% of the loan on payroll for full forgiveness.

**United Mission**

Total UM is \$1,920,815. This is a decrease of (\$271,750) from the prior year. This represents a reduction of 12.39%.
